Explanatory Note

A new version of the North American Industry Classification was introduced with our December 2006 Canadian Business Patterns (CBP): NAICS 2007. From reference periods December 1998 to December 2001, the CBP used the NAICS 1997; from reference periods June 2002 to June 2006, the CBP used the NAICS 2002.

In order to help our clients through the transition to the new NAICS 2007, we have added a few documents under the “NAICS” button in the CBP menu:

- NAICS Changes for 2007
This provides a general explanation for the changes and lists of codes affected
- Establishment Counts for the Concordance:
This provides a list of all affected NAICS 2002 codes and the corresponding NAICS 2007 code(s) along with counts. The counts reflect the December 2006 reference period.

North American Industry Classification System (NAICS) Changes for 2007

The North American Industry Classification System (NAICS) is revised every five years to ensure that the classification continues to reflect changes in the economy.

After considering all proposals from the public, consulting with Statistics Canada (STC) subject matter areas, Canadian data users and industry groups, and undertaking extensive discussions with the United States' Office of Management and Budget (OMB), through its Economic Classification Policy Committee (ECPC) and Mexico's Instituto Nacional de Estadística, Geografía e Informática (INEGI), STC, has developed recommendations for revisions to NAICS.

This notice provides a comprehensive listing of changes for national industries and their concordance to NAICS Canada 2002 industries. [Table 1](#) presents NAICS Canada 2007 industries defined by their NAICS Canada 2002 content. [Table 2](#) lists, in NAICS Canada 2002 order, the disposition of all industries that change and their relationship to NAICS Canada 2007 industries. [Table 3](#) lists the twelve NAICS sectors affected by this revision.

The number and types of changes varies by sector including deletion of NAICS 2002 classes, creation of new NAICS 2007 classes, movement of existing classes, content change to existing classes, and title changes. It is important to note that the majority of changes occur within sector boundaries with two exceptions. Real Estate Investment Trusts (REITs) which move from sector 52, Finance and Insurance to sector 53, Real Estate and Rental and Leasing. Executive search consulting services move from sector 54, Professional, Scientific and Technical Services to sector 56, Administrative and Support, Waste Management and Remediation Services.

The greatest change introduced by this revision is in the area of telecommunications, as was the case in the NAICS 2002 revision. Finally, this revision also allows for updates to the classification contents in general. As necessary, class descriptions will be re-written, old example activities descriptors will be deleted and new example activities added to ensure currency of content
