- Table numbers remain the same as in last year's CD.
- The seasonally adjusted tables in CD1T47 to CD1T54 have been revised back three years (beginning with January 2005) based on the latest seasonal output. Also, all of the seasonally adjusted series have been reviewed for appropriateness, unique seasonal characteristics (such as moving or stable seasonality) and sampling errors associated with specific series that may change over time.
- The monthly seasonally adjusted series by industry, table CD1T48sa, is now available starting in January 1976. Previously it was only available starting in January 1987.
- **Revisions to the estimates for the Yukon**
The estimates for the Yukon have been revised back to January 1995. As the Yukon LFS covers approximately 92% of the population, reduction factors are applied to the total population estimates to reflect this fact. The reduction factors are the ratio of the covered population to the total population from the most recent census. Previously these reduction factors were computed using rounded census counts. The new series being released use population estimates that are computed using reduction factors based on non-rounded census data. Please refer to tables Cd1T30m3 and Cd1T30an for more information.
- **Revision to the estimates for Northwest Territories**
The estimates for the Northwest Territories have been revised back to December 2000. As the Northwest Territories LFS covers approximately 98% of the population, reduction factors are applied to the total population estimates to reflect this fact. The reduction factors are the ratio of the covered population to the total population from the most recent census. Previously these reduction factors were computed using rounded census counts. The new series being released use population estimates that are computed using reduction factors based on non-rounded census data. Estimates from January 2006 onwards have also been revised as the introduction of new questions on immigrants in January 2006 had a minimal impact on the estimates for Aboriginal peoples. - **Revision to the estimates for Nunavut**

The estimates for Nunavut have been revised from January 2006 onwards, as the introduction of new questions on immigrants in January 2006 had a minimal impact on the estimates. Please refer to tables Cd1T30m3 and Cd1T30an for more information.

- The 2007 edition of the *Guide to the Labour Force Survey* (Catalogue no. 71-543) will be released in March 2008 on the Statistics Canada website (www.statcan.ca). Last year's version is included in this CD.

- A new analytical series, *The Immigrant Labour Force Analytical Series* (Catalogue no. 71-606), has been released by the Labour Force Survey. The first issue titled *The Canadian Immigrant Labour Market in 2006: First Results from Canada's Labour Force Survey*, was published on September 10, 2007, with the second and third issues being released in the coming months.

Also being released is the second issue of *Aboriginal Peoples Living Off-reserve in Western Canada: Estimates from the Labour Force Survey* (Catalogue no. 71-587), this spring.
